Introduction: Mapping Environmental Justice (EJ)

- Mapping geospatial data centering environmental justice plays a huge part of understanding how to mitigate climate injustices.
- People using geospatial data can track, and then ultimately manage and measure, the effects of climate change (Ordnance Survey).
- Mapping environmental justice allows one to track things like: environmental risk, air pollution, landscape change, and more.

Introduction: Mapping Environmental Justice (EJ)

- Mapping geospatial data, alongside demographic data provides a better understanding of the social issues that occur in different areas as well.
- This allows us to understand not only environmental concerns, but issues of environmental injustice; we learn what groups are most affected, and how we might mitigate these consequences.

Introduction: Mapping Environmental Justice (EJ)

The two landmark studies that were said to start the field of EJ examined the inequitable placement of environmental harms on communities of color; take a second to look at the EPA's timeline of these cases:

- a. Siting of Hazardous Waste Landfills and Their Correlation with Racial and Economic Status of Surrounding Communities (General Accounting Office, 1983).
- b. Toxic Waste in the United States (United Church of Christ, 1987) - this report coined the term "environmental racism"

Highlights

- There is a world movement for environmental justice.
- Over 3300 ecological distribution conflicts are recorded in the atlas of environmental justice.
- Such conflicts particularly occur at the frontiers of commodity extraction and waste disposal.
- Political ecology studies such conflicts, and should be placed at the centre of politics.

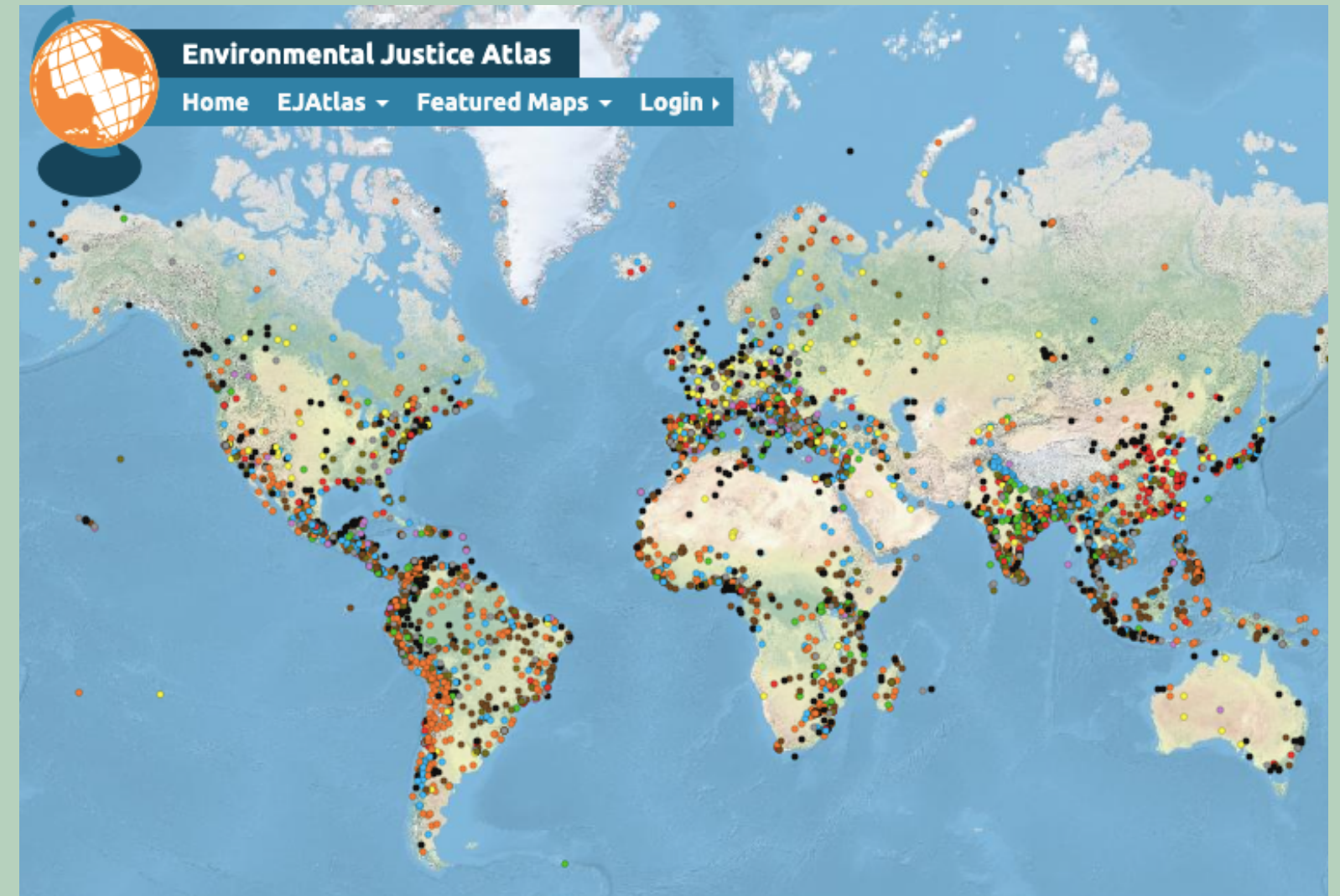

Overview of EJAtlas

The EJAtlas is an online platform and tool developed to make visible and systematize contemporary struggles against environmental injustice worldwide—with and for affected groups

With over 3800 (and counting) cases uploaded to EJAtlas, EJAtlas documents social, often invisible, conflicts around environmental issues worldwide.

Users can explore the page by kinds of issues, country maps, and more.

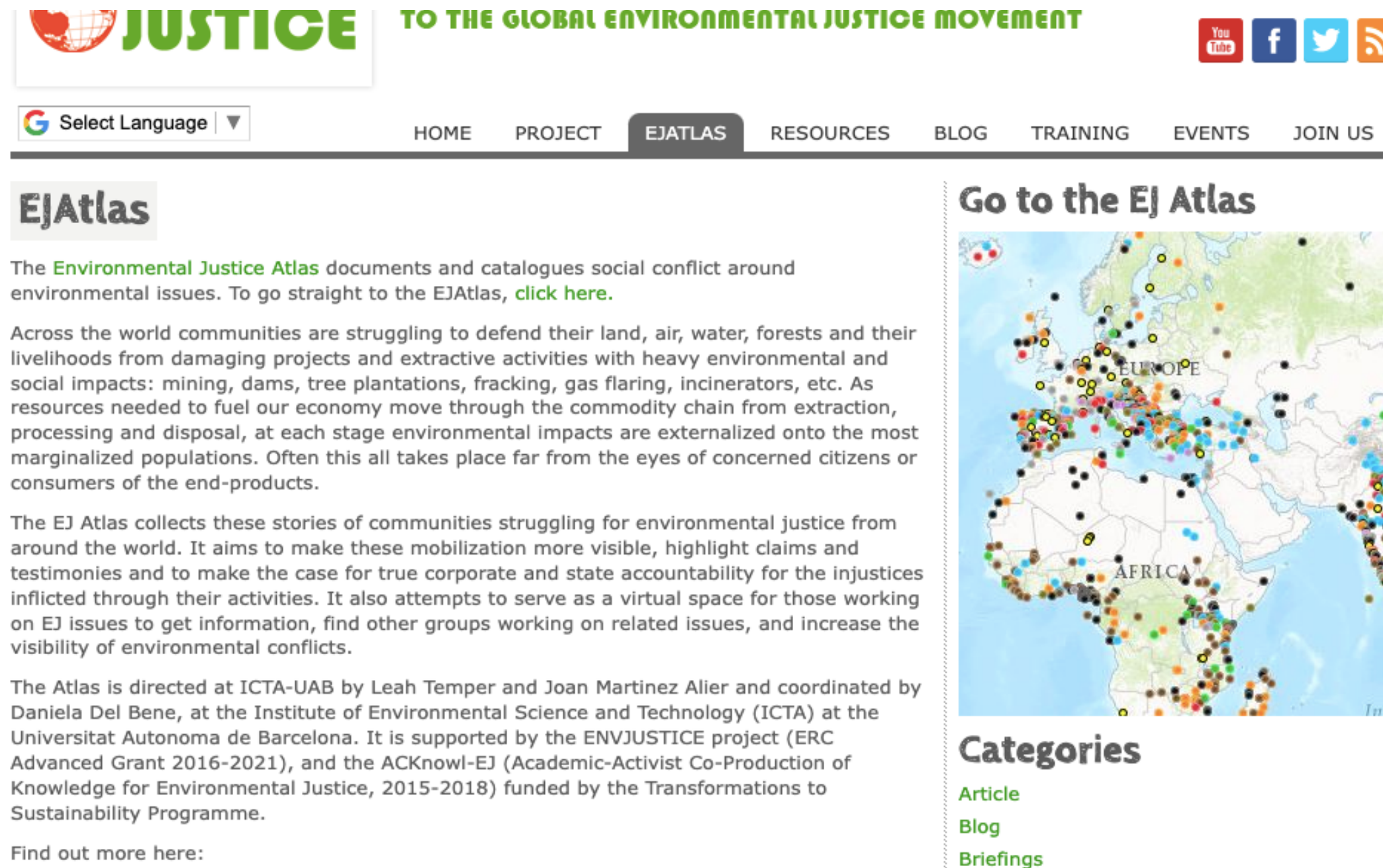

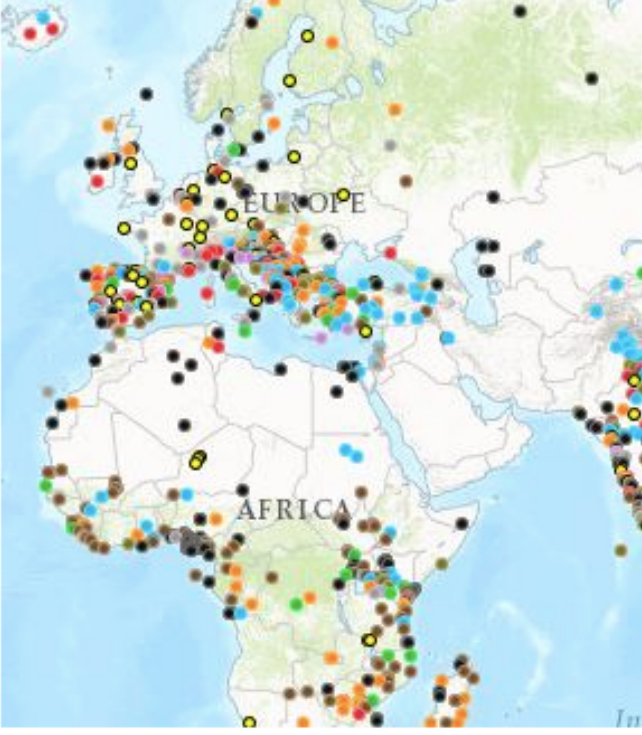
Across the world communities are struggling to defend their land, air, water, forests and their livelihoods from damaging projects and extractive activities with heavy environmental and social impacts: mining, dams, tree plantations, fracking, gas flaring, incinerators, etc. As resources needed to fuel our economy move through the commodity chain from extraction, processing and disposal, at each stage environmental impacts are externalized onto the most marginalized populations. Often this all takes place far from the eyes of concerned citizens or consumers of the end-products.

The EJ Atlas collects these stories of communities struggling for environmental justice from around the world. It aims to make these mobilization more visible, highlight claims and testimonies and to make the case for true corporate and state accountability for the injustices inflicted through their activities. It also attempts to serve as a virtual space for those working on EJ issues to get information, find other groups working on related issues, and increase the visibility of environmental conflicts.

The Atlas is directed at ICTA-UAB by Leah Temper and Joan Martinez Alier and coordinated by Daniela Del Bene, at the Institute of Environmental Science and Technology (ICTA) at the Universitat Autònoma de Barcelona. It is supported by the ENVJUSTICE project (ERC Advanced Grant 2016-2021), and the ACKnowl-EJ (Academic-Activist Co-Production of Knowledge for Environmental Justice, 2015-2018) funded by the Transformations to Sustainability Programme.

Take 15 minutes to look through the EJAtlas to familiarize yourself with the platform.

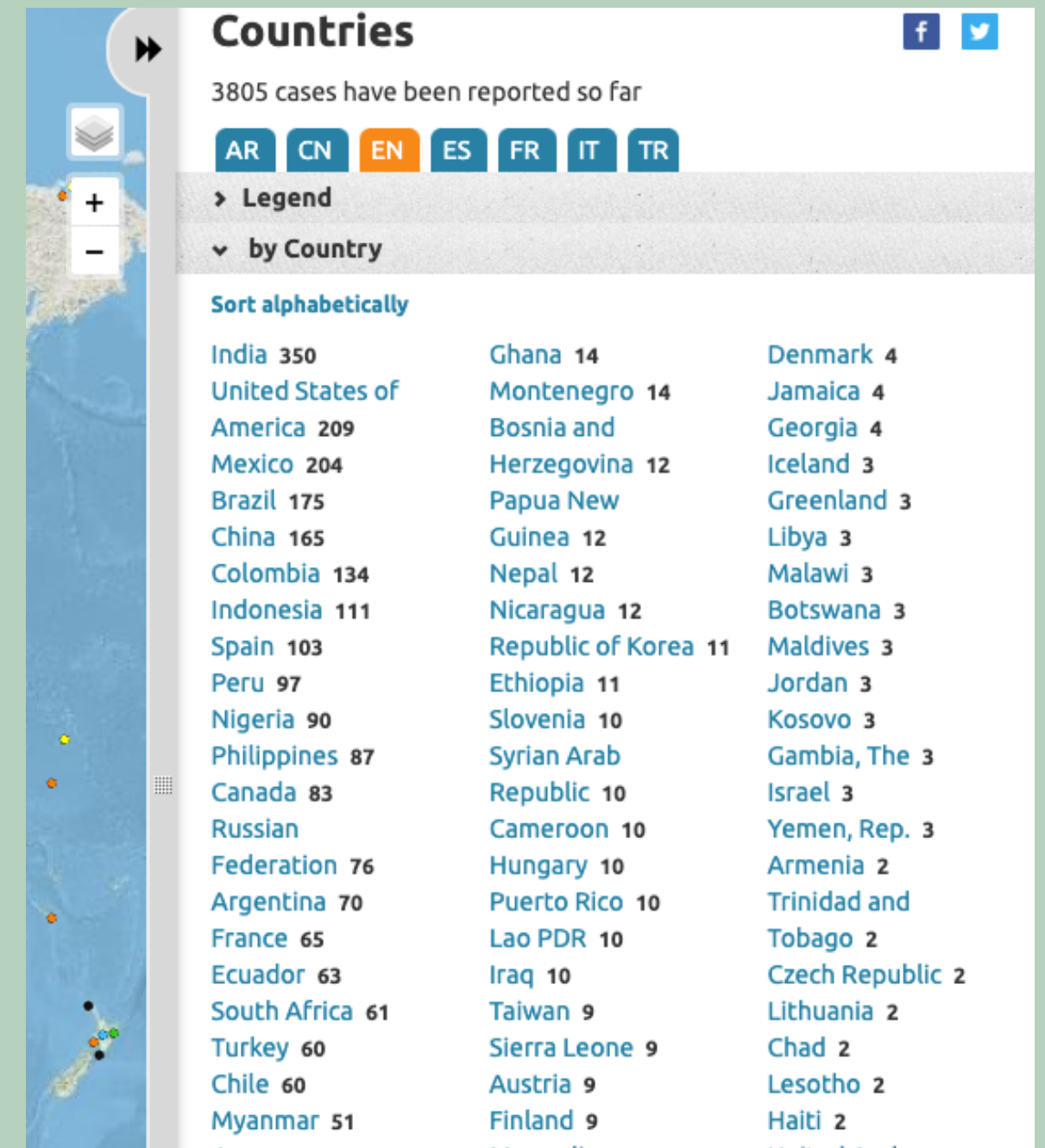
Initial Guiding Questions:

- What kinds of case studies does the platform show in the legend?
- Are there any important ones you can think of that aren't on EJAtlas already?
- What trends and patterns do you notice? One trend might be that certain countries see a certain kind of problem more prominently.
- What qualifies as an EJ conflict or not?



Activity 4: Country Maps + Mini-Presentation

- Split up into groups of 3, and pick a country to explore more deeply. Take 20-30 minutes to take more detailed look at the case studies that pop up, and see what trends you find across the country.
- With your group of 3, you'll have a mini-share out on your findings to the rest of the class. Share at least one case study, and then discuss the trends.
- To divide by country, click on 'Featured Maps', and 'Country Maps'.



Activity 5: Picking a Case Study + Dyad!

Choose a case study that interests you from around the world. Spend 10 minutes looking through it, looking at news stories from it (under 'Sources and Materials') then consider:

- a. Why did you choose this case?
- b. What environmental injustice struggle is happening? Why? What role does power at play in this case?
- c. What are the potential solutions to this case, what tools from your current course/major of study would be helpful in addressing the problems? Why?
- d. What aspect of environmental or climate justice did you learn while investigating this case?

As a follow up to this activity, participate in a 2 minute dyad, where in pairs you will each have 2 minutes to talk about your thoughts about these questions.

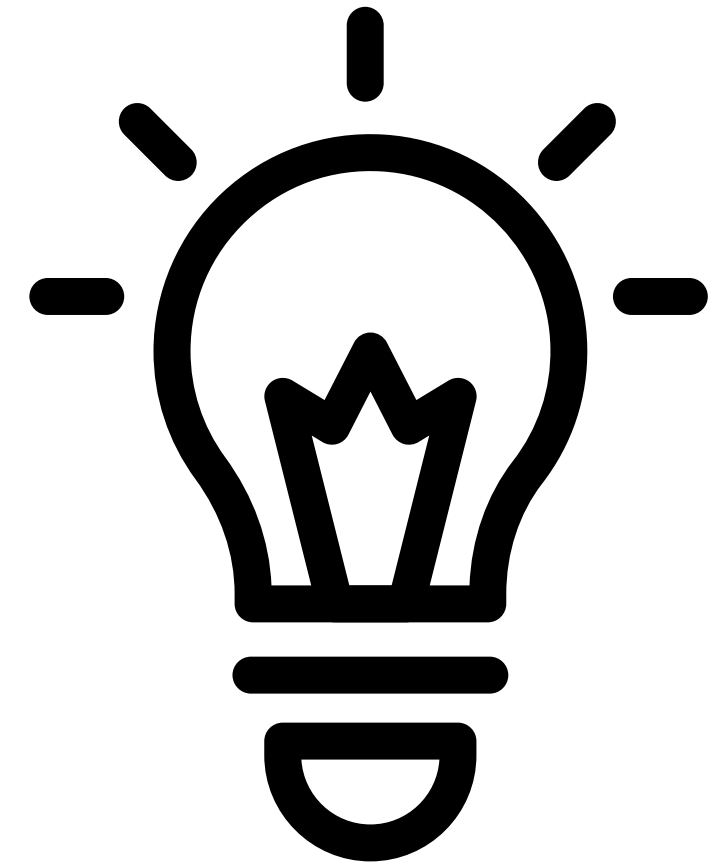
Listeners should not interject, and instead focus on being an active listener.

2. What suggestions might you have for improving a tool like EJ Atlas?





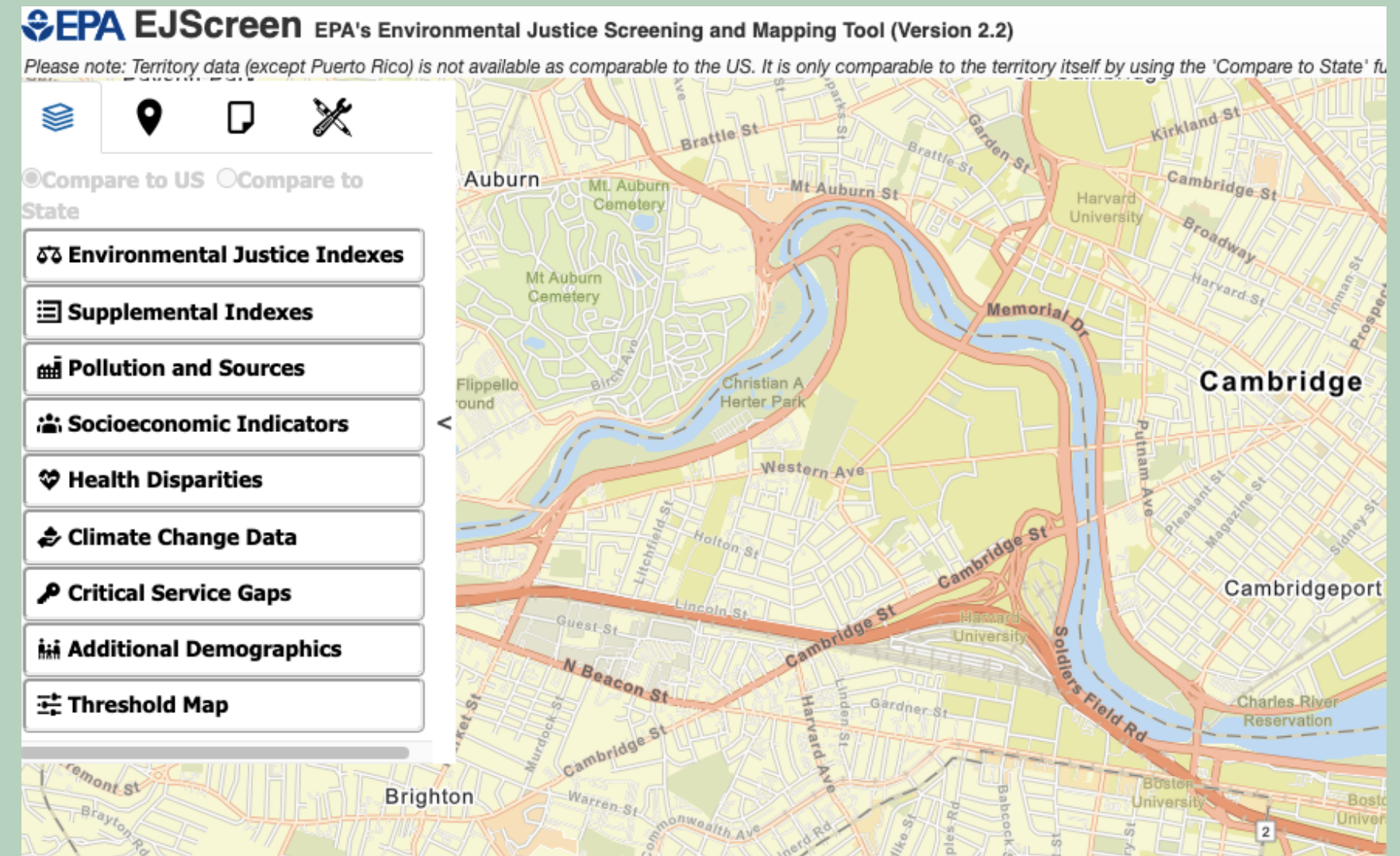

EJScreen

Overview of EJScreen

- EJScreen is an EPA's environmental justice mapping and screening tool that provides EPA with a nationally consistent dataset and approach for combining environmental and demographic socioeconomic indicators.
- EJScreen users choose a geographic area the tool then provides demographic socioeconomic and environmental information for that area.
- All of the EJScreen indicators are publicly-available data. EJScreen simply provides a way to display this information and includes a method for combining environmental and demographic indicators into EJ indexes.'

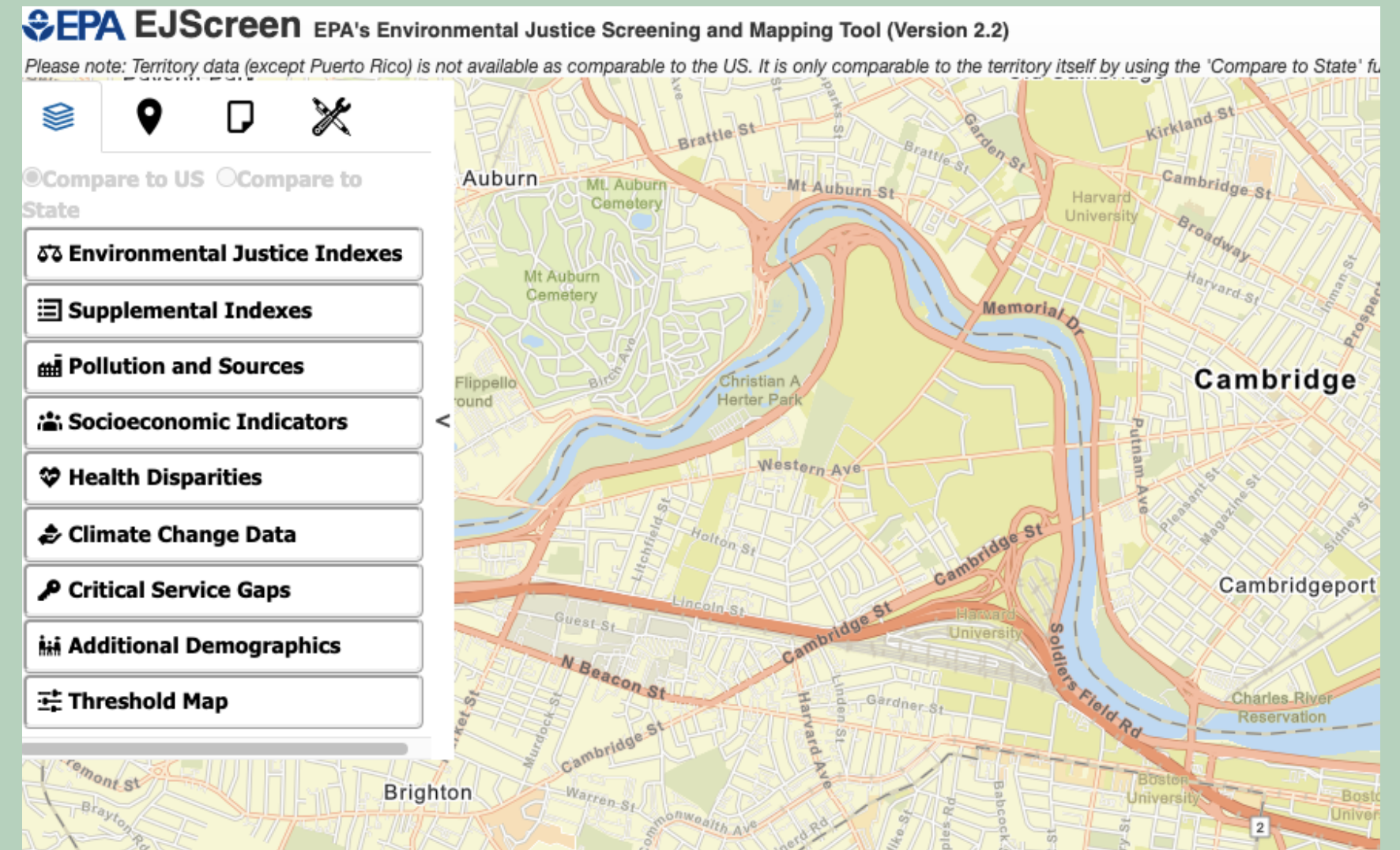

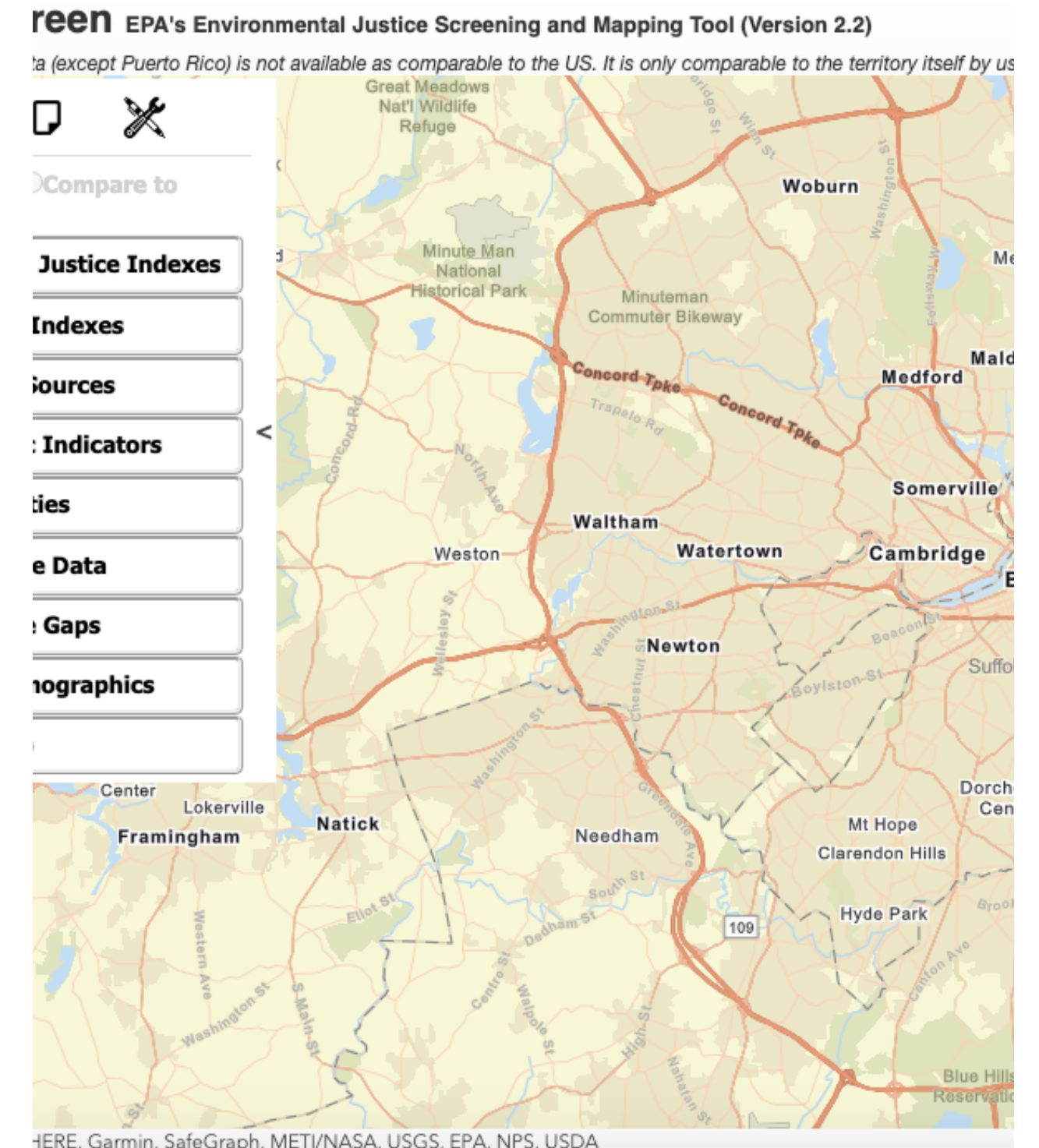

Activity 8: Case Studies + Class Presentation

Considerations to make while curating your presentation:

- How is this a problem of environmental justice? What resources are being utilised? *Who* is most affected?
- Trace the problem back- where did the case study you chose originate? Who/what were factors/perpetrators?
- Use other indexes to help! Take a look at schools, prisons, hospitals, in areas around where your study is located, etc, and see what you find (Click on the location icon entitled 'places'). Whatever can help inform your research is great!

Abstract

The Biden-Harris administration has focused considerably on environmental justice (EJ), including the Justice40 Initiative and renewed White House Council on Native American Affairs. This work has included financial investments in Tribal economies, prioritizing Tribal health care, and major Tribal infrastructure investments as part of current passed bills and active proposed legislation. The Justice40 Initiative aims at delivering at least 40% of the benefits of federal investments in climate and energy to disadvantaged communities, including many Tribes. The recent White House Tribal Nations Summit Progress Report discusses Justice40 and its potential benefits related to climate, energy, transportation, housing, pollution, and infrastructure. The report leaves open the question of how Tribes will benefit from Justice40. Currently, the White House Council on Environmental Quality is developing a new Climate and Economic Justice Screening Tool for identifying disadvantaged communities who qualify for Justice40 investments. Executive Order 14008 references how this new screening tool should be based on lessons learned from EJSCREEN. For Tribes, however, EJSCREEN does not adequately represent infrastructure and other EJ needs relevant to the goals outlined in Justice40. In this article, we will discuss issues with EJSCREEN that must be addressed in the forthcoming screening tool that was released in prototype form for public comment on February 18, 2022. Major gaps in EJSCREEN include ones in data regarding mining, energy extraction, cultural landscapes, meaningful spatial boundaries, and qualitative data in general, as well as the fundamental issue of engaging with Tribes. These concerns must be addressed if Tribes are to be accurately represented by the tool such that they may fully benefit from Justice40 investments. However, there may be ethics and sovereignty issues that will make some data unavailable at the national scale, or shortages in the United States and Tribal capacity to coordinate the formation of data sets.

- How could these mapping tools help us take action at an individual, social or political level?



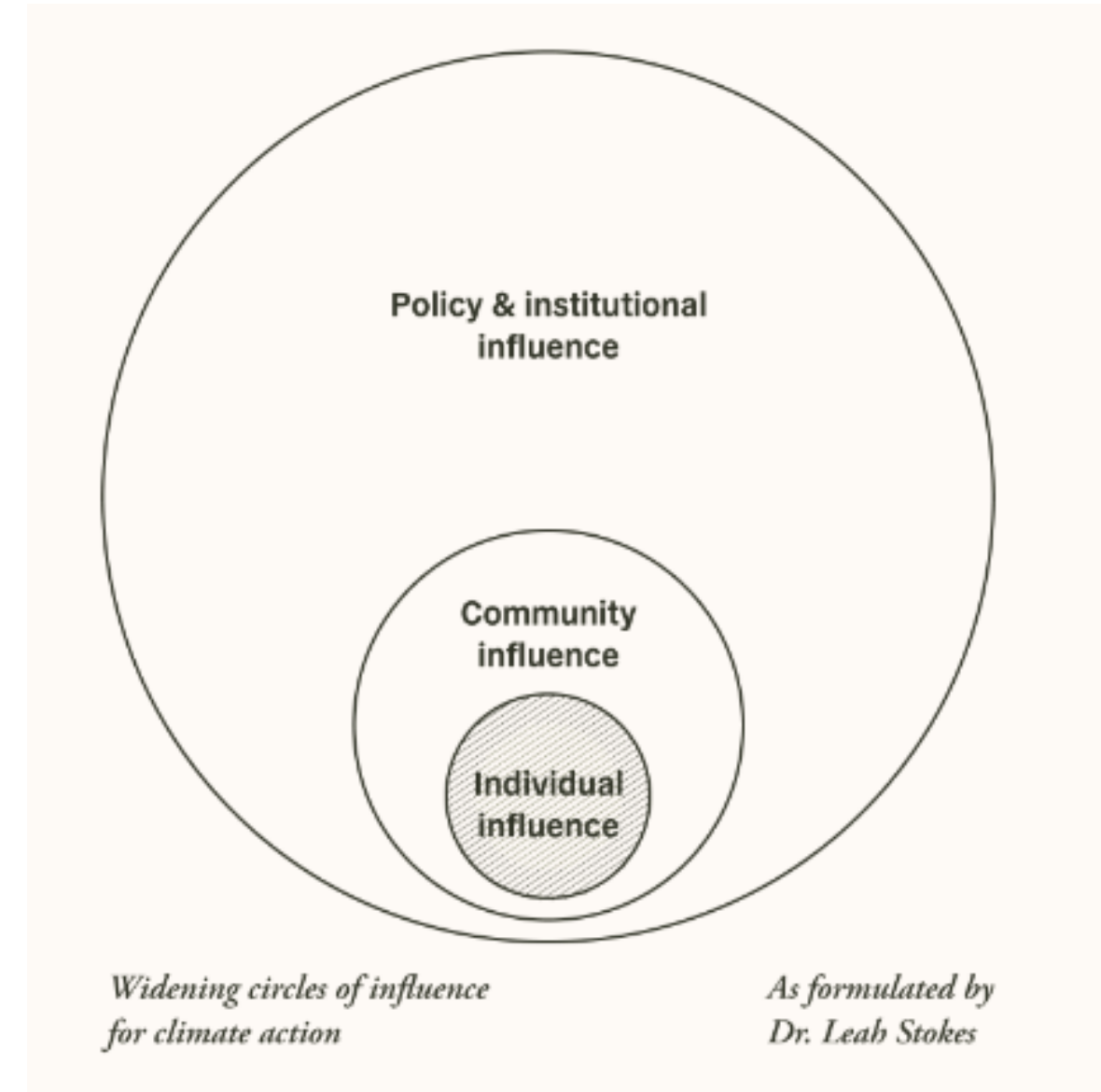

Taking Action: EJScreen

Using EJScreen, take a look at some issues in the Cambridge area/ near MIT (or potentially another area)

- Learn about MIT's impact. (You could also focus on the impact of any institution or organization)
 - Research how MIT relates to or engages with the issue you researched. If they don't, research how they can get involved.
 - Prepare a short presentation of your findings, and share it with the class.
- Make a recommendation for how MIT can advance climate solutions to this issue.
 - Tap into the power of radical imagination: What would it look like for your school to be in alignment with a just and livable future? Who has the power to make that so? Are there any efforts already working towards this outcome? How could those efforts be expanded?
 - Write an open letter presenting your proposal. Be sure to include what you learned in the first point in the assignment, about the area of impact you researched.
